**C. Minutes:**

**C.1 Special Meeting - March 15, 2013**

Member Bonsall moved to approve the minutes of March 15, 2013, meeting of the Casa Grande Police Personnel Retirement Board. Member Miller seconded the motion and was carried with a 3-0 voice vote.

**D.1 Review and Discussion on Appropriate Action Regarding Hiring of Public Safety Personnel Retirement System (PSPRS) Retired Member Johnny Cervantes to Ensure Compliance with Return to Work (A.R.S. 38-849D)**

Member Miller provided the Board in their agenda packet copies of A.R.S. 38-849D and Public Safety Retirement System's Frequently Asked Question - Return to Work, for their review and discussion regarding the hiring of Public Safety Personnel Retirement System Retired Member Johnny Cervantes to ensure compliance with Return to Work per A.R.S. 38-849D.

Member Miller reported that Johnny Cervantes on March 29, 2013 retired from City of Scottsdale Police Department as a Member of the Public Safety Retirement System (PSPRS) for twenty five (25) years.

Member Miller conveyed that Johnny Cervantes date of hire as the City of Casa Grande Police Chief is April 2, 2013.

Member Miller reported that per Administrative Services Director Dawn Jett, the City of Casa Grande will provide alternate contribution rates towards Johnny Cervantes' retirement benefits as a new hire for the City of Casa Grande Police Department, since Mr. Cervantes is currently receiving pension benefits as a retired member of the Public Safety Personnel Retirement System (PSPRS).

The Board acknowledged that Johnny Cervantes is a new hire/return to work for the City of Casa Grande Police Department as Police Chief. Further, Johnny Cervantes, as a retired member of the Public Safety Personnel Retirement System (PSPRS) cannot contribute to PSPRS; however he will receive alternative contributions from the City of Casa Grande.

Member Bonsall moved to accept Johnny Cervantes as a new hire for the City of Casa Grande Police Department as Police Chief, and has met the compliance of Return to Work per A.R.S. 38-849D as a retired member of the Public Safety Personnel Retirement System (PSPRS). Chairman Jackson seconded the motion and was carried by a 3-0 vote.
