COMPUTER AIDED DISPATCH/RECORDS MANAGEMENT SYSTEM (CAD/RMS)

The City of Casa Grande is seeking proposals from experienced, qualified, and motivated vendors to provide and implement a Computer Aided Dispatch/Records Management System (CAD/RMS) for use by public safety (police, fire, and dispatch) personnel.

Val Vista Blvd., Casa Grande, AZ 85122. Pre-submittal questions must be submitted by **January 19, 2015**. Responses to questions will be given during the pre-submittal conference and posted online.

Proposals must be in the actual possession of the City Clerk by **2:00 p.m., (local city time) on March 4, 2015**, at 510 E. Florence Blvd., Casa Grande, AZ 85122. Offers must be submitted in a sealed package with the Offeror's name, address, and title of the description clearly indicated. Late proposals and fax or email proposals will not be considered. Proposals should be in printed format and electronic format. A total of five (5) hard copies are required with at least one (1) of those copies unbound for easy duplication for reviewing purposes. The Functional Requirements workbook (Submittal 4) must be submitted in Microsoft Excel, and provided in electronic media (CD, DVD, thumb-drive, etc.).
